Job Duties:	The project will encompass the synthesis of WCA-NHCs and boryl anions including a systematic variation of substituents for structure-activity studies. The obtained ligands are planned to be introduced into Ru-complexes endowed with a reasonable set of co-ligands, and will be tested in catalytic reactions (olefin metathesis).  Post-doc task will be to synthesize the boron compounds for utilization as a ligands in transition metal complexes.
